History

The Center for Access to Justice and Technology (CAJT), formerly Justice Web Collaboratory, was formed at Chicago-Kent in 1999. The CAJT worked to make justice more accessible to the public by promoting the use of the Internet in the teaching, practice, and public access to the law. The CAJT conducted research, built software tools, taught classes, and supported faculty, staff, and student projects on access to justice and technology.

The first major focus of the CAJT was Meeting the Needs of Self-Represented Litigants: A Consumer Based Approach, or the "Meeting the Needs" project. The project investigated barriers to access to justice facing self-represented litigants, applied system design methodology to redesign court processes, and built an Internet-based prototype for implementation by the courts. The first phase of the project began in August 2000 with a course taught by Professor Ron Staudt, the Justice Web Collaboratory Interprofessional Research Opportunity (IPRO). In the class, 13 law students from Chicago-Kent and 5 graduate design students from the IIT Institute of Design explored existing *pro se* assistance programs by observing the Chicago-Kent Advice Desk at the Richard J. Daley Center, and gathering information from litigants and courts in Cook and Lake Counties, Illinois; Delaware; Boulder County, Colorado; and Ventura County, California. Using data collected during the site visits, students identified the factors restricting access to justice and created solutions based on information structure, and finally constructed a communication document for their ideas to overcoming these factors. A second course in Systems Design and Structured Planning, taught by Charles Owen at the Institute of Design, began in January 2001, and consisted of 22 graduate-level students, including four law students from Chicago-Kent College of Law and 18 design students from the Institute of Design. In this second phase of the project, under the supervision of Professor Ron Staudt, Professor Charles Owen, and Edward B. Pedwell, the project team used the data gathered by the IPRO course and their own site visits to create the Access to Justice system. The full report on this project, *Access to Justice: Meeting the Needs Of Self-Represented Litigants*, was published in 2002 by Owen, Staudt, and Pedwell. The third



and final phase of the project was the development of A2J Author, a software tool that enabled non-technical authors to create web-based interfaces for document assembly. The software was developed in partnership with the Center for Computer-Assisted Legal Instruction (CALI) and launched in 2005. The CAJT continues to manage and promote A2J Author.

In 2003, an Illinois Joint Simplified Dissolution of Marriage Prototype (“JSDM Prototype” was created. The prototype was custom-designed software that provided a web-based interface for completion of the forms required for joint simplified dissolution of marriage in Illinois. In 2004, the Self-Help Web Center (SHWC), a help desk located on the 6th floor of the Circuit Court of Cook County at the Richard J. Daley Center, was created and launched. The SHWC serves as a starting point for *pro se* litigants and assists visitors in finding legal information and completing online legal forms.

Scope and Contents

Series I: The Access to Justice Project series is arranged into five subseries, each arranged chronologically. This series contains materials pertaining to each phase of the Access to Justice Project.

Subseries I. The Administrative subseries consists of correspondence related to all phases of the Access to Justice/Meeting the Needs project. Also included are financial materials, such as grant applications, budget materials, and expense reports. Quarterly reports of the phases of the project, curriculum planning materials for the IPRO and ID courses, and concept materials are also arranged within this subseries.

Subseries II. The IPRO 380 Course Materials subseries includes research and documentation of the activities of each of the five teams of students in the Fall 2000 IPRO course. Final reports from each team are arranged within team materials, with a final report on the first phase of the Access to Justice/Meeting the Needs project is arranged at the end of the subseries. Administrative materials for the course, such as attendance lists and syllabi, are arranged at the beginning of the subseries.

Subseries III. The ID 589 Course Materials subseries includes course planning materials and handouts, as well as materials from design workshops and detailed student work on the Access to Justice/Meeting the Needs project. Also included in this subseries are materials from an in-progress review of the project, as well as final presentation materials.

Subseries IV. The Access to Justice Design subseries includes materials related to the design of a prototype software based on the research of the IPRO and ID courses. Planning materials for this phase of the project are included, as well as several prototypes with design revision notes. A report on the first two phases of the Access to Justice/Meeting the Needs project is arranged at the beginning of the series.

Subseries V. The Published Materials subseries includes both draft and published versions of the full report on the findings of the IPRO and ID courses, *Access to Justice: Meeting the Needs of Self-Represented Litigants*. Also included is a folder of correspondence related to the publication and printing of this material.

Series II. The Conferences series is arranged into two subseries.

Subseries I. The International Conference on Substantive Technology in the Law School subseries includes material from the first four annual conferences, which were attended by CAJT founders. The bulk of the material in this subseries is related to the second annual conference, which was hosted at the Chicago-Kent College of Law in 1992. This subseries includes information on conference planning and presentation materials, as well as correspondence related to each conference.

Subseries II. The Judicial Decision Support Systems Symposium (JDSS3) series includes materials from the third annual conference, which was held at Chicago-Kent College of Law in 2001. This subseries includes information related to conference planning, as well as presentation materials.

Series III. The Self-Help Web Center materials include research pertaining to the establishment of a web resource for *pro se* litigants in the Daley Center, to be managed by Chicago-Kent College of Law students as a part of the Advice Desk. The series includes an overview of the Advice Desk, grant and funding materials, and a training manual for Self-Help Web Center employees.

Series IV. The Justice Web Collaboratory series includes a small amount of material related to the redesign of the Justice Web Collaboratory website, as well as some financial materials.
