Researchers from all over the world continue download and cite our growing contributions to legal scholarship on a daily basis. Our past achievements, historical documents, esteemed Law Reviews, and other intellectual output of the Law School are now available on a global level. Our download counts indicate that we have been very successful in our mission to provide open

access to the scholarship in our repository.

Preserving our history and our contribution to the field of legal scholarship online remains impossible without the participation and interest of our faculty and administration.

Scholarly Commons @ Chicago-Kent College of Law is the institutional repository for the Law School's intellectual work and contributions to the field of law. Research and scholarly output has been selected and deposited by the individual university departments on campus. This report highlights the major accomplishments of Scholarly Commons during the period from April 2015 to April 2016.

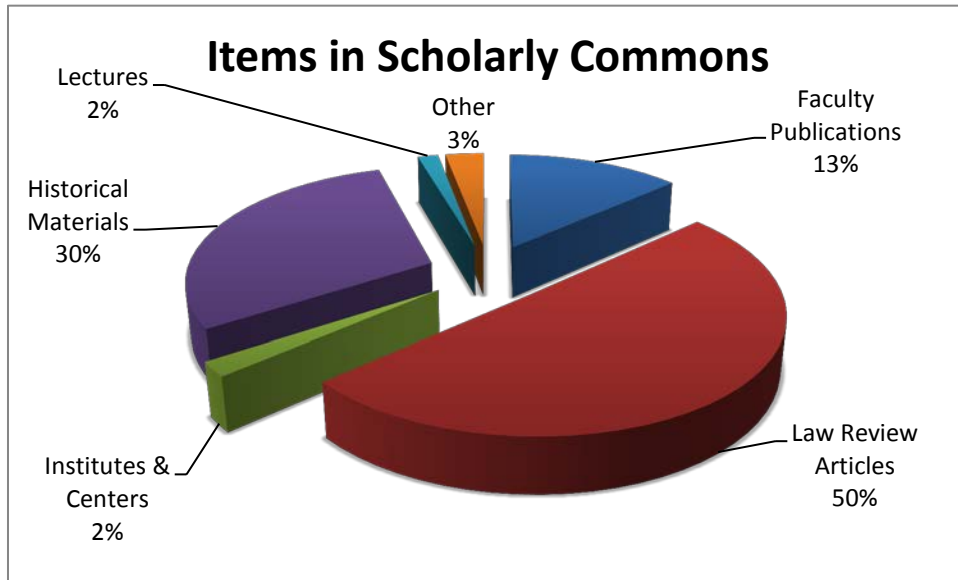

Major Collections in Scholarly Commons

Faculty Scholarship

The Faculty Scholarship series includes articles, book chapters, briefs, and popular media written by faculty. Each article deposited in Scholarly Commons has been posted by permission of publishers. Faculty authors receive download counts via email directly from Bepress, combined with Selected Works download count data.

Securing self-archiving rights and posting faculty articles in Scholarly Commons not only makes Chicago-Kent College of Law more visible to members of the Law School community, it also broadens the audience to include researchers from across the globe. Each article deposited in Scholarly Commons is permanently linked in that location and will never be moved or changed. Citations to that article will

always lead back to the reliable source. Creating a permanent, functional archive of our faculty's work means that it will be available to researchers for years to come.

Number of items in Faculty Scholarship: 856

Institutes & Centers

The Institutes & Centers collections include materials produced by the various activities of the esteemed institutes and centers at Chicago-Kent College of Law. Currently, the community hosts event photos and videos, conference proceedings, and symposia sponsored by the Institute on the Supreme Court of the United States (ISCOTUS), the Institute for Law and the Workplace, and the Center for Empirical Studies of Intellectual Property.

Number of items in Institutes & Centers: 211

Journals & Law Reviews

Scholarly Commons hosts the complete run of two of Chicago-Kent's esteemed student journals, the *Chicago-Kent Law Review* and the *Chicago-Kent Journal of Intellectual Property*.

The Chicago-Kent Law Review

The *Chicago-Kent Law Review* began as the "Chicago Kent Review" in 1923. By the 1930s, the journal had adopted its current name and began publishing scholarly articles by law professors and practitioners. Articles appear in an all-symposium format, produced by students under the direction of a faculty editor. Each issue also contains a select number of student articles that the executive board chooses on the basis of contributions to legal scholarship.

The Chicago-Kent Journal of Intellectual Property

The mission of the *Chicago-Kent Journal of Intellectual Property* is to present both in-depth analyses of fundamental issues affecting intellectual property rights, and timely, succinct analysis of current intellectual property issues.

Number of items in the Chicago-Kent Journal of Intellectual Property: 156

Conferences & Lectures

The Conferences & Lectures collection contains materials from the many well-established academic lecture series and conferences hosted by Chicago-Kent throughout the year. Currently, the community hosts video of Constitution Day lectures and presentations, videos of the Centennial Lecture, the Charles E. Green Lecture in Law & Technology, proceedings of the Futures Conference, and video recordings of the Morris Lecture in International and Comparative Law and of the Palmer Prize Lecture. Video files preserved in the repository are also available to stream online so that users may enjoy them without downloading.

Number of items in Conferences & Lectures: 52

History & Archives

The Chicago-Kent College of Law Archives has an active digitization system. Over the last year, several archival volumes and collections, from back issues of *The Record* to issues of *The Transcript* from 1917-1924, have been carefully digitized and uploaded to the repository. These items are now available for browsing and full color PDF copies can be downloaded from the repository. Our 125-year history becomes more accessible to staff, alumni, and the community every day.

Number of items in History & Archives: 1130

Looking Forward

This year, we increased the size of the repository by nearly 17%, adding over 613 items: faculty scholarship, conference materials, journal articles, and historical items. Our download counts between this year and last year increased by over 341,000. The *Seventh Circuit Review* was established, bringing materials that had been available on the Chicago-Kent website into the wider realm of open access with inclusion in Google Scholar, and higher visibility in Google search results. Content from the Faculty Scholarship collection was frequently featured in the “Top Schools” section of Law Commons based on popularity in download counts.

Some of the largest download counts came from items shared via links on social media, including Twitter and Facebook. Next year, we hope to make our collections more visible through these avenues, and reach an even wider audience through shares of our collections and items. We aim to increase the repository size further with an emphasis on faculty scholarship, and we also intend to investigate the opportunities that may be available to digitize and host collections of legal material that previously existed only in print format, have not been archived by another institution, or have been otherwise difficult to access.

Meeting Strategic Goals

Scholarly Commons at Chicago-Kent College of Law meets two of IIT’s strategic priorities:

- Elevate IIT’s visibility and reputation

The collections hosted in Scholarly Commons have attracted a new and diverse audience to the Law School. Genealogists, alumni, and descendants of alumni have contacted the Archives to learn more about the materials they found there. The Law Reviews saw an increase in downloads and shares on social media. Researchers from other countries and institutions have relied on the scholarship found in the Faculty Scholarship collection. The visibility of the Law School and its contribution to legal scholarship has increased in both attracting new audiences at home and expanding the reach of our collections to other countries.

- Develop resources to enable progress

Scholarly Commons should be seen as a resource for the Law School , its students, staff, and faculty. Many departments and groups are already represented, and we will expand the use of the repository as a resource to everyone. We intend to add collections of student materials, create spaces for the output of more institutes and centers, and are open to learn how the repository as a resource can benefit any and all groups on campus.
