### Scholarship Cup Again Goes to Phi Delta Phi

A compilation of the averages of the members of the different fraternities reveals the fact that history does repeat itself. Phi Delta Phi again heads the list, with a fraternity average for the second semester of 1927-28 of 1.772. The fraternity averages for the second semester are as follows:

Phi Delta Phi was awarded the scholarship cup both semesters of the college term of 1927-28, and has now won the coveted trophy for scholarship attainments four times. Nu Beta Epsilon has been awarded the cup on three occasions, Delta Chi twice and Phi Alpha Delta once.

The cup was first presented to the Trustees of the College in 1924 by Fuller's Inn of Phi Delta Phi fraternity, to be awarded each semester to the fraternity represented at Chicago-Kent College of Law having the highest scholastic standing.

There are represented at Chicago-Kent College of Law seven legal fraternities and a chapter of Kappa Beta Pi, woman's legal fraternity, as listed above in the scholarship rankings.

So far the scholarship cup has only been awarded to four of these organizations. The principal purpose for which the cup was donated—to awaken a keen spirit of competition among the students and fraternities, will be unavailing if the cup does not circulate among all the fraternities at Kent. It is hoped that the competition for the cup will become so spirited that, in the semesters to come, eventually it will have been awarded at some time or other to each of the fraternities.
