Arthur S. Welch, C'93, now resides in London.

Walter B. Smith, C'94, formerly Senior Title Officer of the Chicago Title & Trust Company has become a member of the firm of Altheimer & Mayer. Mr. Smith succeeded Mr. R. W. Boddinhouse on the faculty of Chicago Kent College of Law as head of the department of Real Property Law in the year 1920.

The college is informed that Eli E. Lindsay, K'95, has passed away.

Dr. G. E. Wire, K'95, has retired as librarian of the Worcester County Law Library after over thirty years of service with that library. Dr. Wire is widely known among the law librarians of the United States and Canada, and took a deep interest in the American Association of Law Libraries. He was elected to the Circuit Court bench in 1915 and assigned to the Juvenile Court. During the past two years he was chief justice of the Circuit Court. He was also instrumental in securing the annual county appropriation for placing orphans in private homes and the mothers' pension fund.
