ALUMNI NEWS

BRYAN Y. CRAIG, '91, died November 25, 1931. Mr. Craig received an LL.M. degree from the College in 1891. He was a member of the firm of Weissenbach, Hartman, Craig and Okin and a member of the American, Illinois, and Chicago Bar Associations.

EDWIN A. MUNGER, '92, died in Chicago, September 18, 1930. Mr. Munger was admitted to the Bar of Illinois on January 13, 1892, and he practiced law in Kansas for a few years following his admission. He returned to Chicago and devoted himself to the practice here. For many years his practice was in Chancery, and in 1918 he was appointed Master in Chancery by Judge Thomas Taylor, Jr., which office he held until his death. Mr. Munger was the author of two volumes of verse published during his lifetime, *Along the Shore* and *A Family Garden of Verse*.

HON. HENRY HORNER, '98, Judge of the Probate Court of Cook County, is a candidate for the Democratic nomination for Governor of the State of Illinois.

SAMUEL B. KING, one of the incorporators of the Kent College of Law, died in Chicago, January 7, 1932, after a long illness. Mr. King was born May 2, 1865, at Salem, Massachusetts. Coming to Chicago with his parents in 1871 he was educated in public schools of the village of Hyde Park. Later he studied law in the offices of Doolittle and McKey and was graduated from the Union College of Law in 1887. From 1914 to 1925 he was the senior member of the firm of King, Brower and Hurlbut and in 1926 was a candidate for municipal judge. He is said to have had ten cases of the first instance before the Illinois Supreme Court. Mr. King went to France last summer in the hope of improving his health and since his return has been confined to his home at 5417 Blackstone Avenue. He was a member of the American, Illinois, and Chicago Bar Associations and was formerly Commodore of the Chicago Yacht Club.

LEO J. DOYLE, '02, passed away at his home in Chicago, December 30, 1931. Mr. Doyle was admitted to the Bar in 1902 and some years later became Master in Chancery in the Superior Court. In 1914 he became judge of the Municipal Court of Chicago, which office he held until 1920. He was an assistant corporation counsel at the time of his death.

GUY GUERNSEY, '04, has announced his candidacy for trustee of the Sanitary District of Chicago.

HON. JAMES F. FARDY, '07, will be a candidate for re-election to the office of Judge of the Municipal Court.

The College regrets to announce the death of PATRICK J. MURPHY, '09, on May 1, 1931. Mr. Murphy served as Assistant State's Attorney under Maclay Hoyne for several years. He was a member of the firm of Peden, Murphy and Ryan.

JULIUS M. LISON, '13, died suddenly December 3, 1931.

ROBERT C. HARDY, '15, is attorney for the Boys and Girls Anti-Cigarette League and is engaged in prosecuting cases of illegal selling of cigarettes.

THOMAS J. DOYLE, '21, is a candidate for the Democratic nomination for representative from the tenth congressional district.

HEBER E. PALMER, '23, is now located in Salt Lake City, Utah.

ERWIN H. WRIGHT, '25, and Emil Kamin are now associated as the firm of Wright and Kamin with offices at 160 N. La Salle Street, Chicago, Illinois.

WILLIAM M. JAMES, '25, is a candidate for the Republican nomination for representative in the General Assembly from the seventh senatorial district of the State of Illinois.

THOMAS J. COURTNEY, '26, is a candidate for State's Attorney of Cook County, Illinois.
