UNDERGRADUATE NEWS

THOMAS A. MORAN PRIZES

In memory of the late Hon. Thomas A. Moran, Dean of the College from 1896 to 1904, prizes are offered aggregating the sum of three hundred dollars to undergraduate students who rank highest in scholarship and who evidence ability in research. These prizes are paid from the income realized from a fund contributed by members of Judge Moran's classes. One of these prizes was awarded to Paul Francis Kinnare of the class of February 1932. Two other of these prizes were awarded, in the order named, to Roger L. Severns and Harvey Hammond Talcott, members of the class of June 1932. Each of these prizes consisted of a scholarship in the graduate department for the ensuing year.

GRADUATE SCHOLARSHIP PRIZES

The College offers graduate scholarships during the ensuing year to members of the graduating class who rank high in proficiency in scholarship and general research. The prize for the February class of 1932 was awarded to Allan Adolphus Klove. Prizes for the class of June 1932 were awarded to Marjorie Grosvenor Van Horne and Grove G. Talcott.

SOCIETY OF KENT HONOR MEN

Nomination to this society is based upon general attainment as well as scholastic excellence and proficiency in research. Election to the society follows after one year provided the nominee produces, under the direction of the faculty, a law study worthy of publication in the Chicago-Kent Review. For those not already awarded scholarships, nomination entitles the nominee to a partial scholarship in the graduate department. The faculty has announced the following nominations: Leonard A. Ash, Layman Lamphier Hay, Paul Francis Kinnare, Allan Adolphus Klove, Paul McReynolds Jones, Foorman Lloyd Mueller, Roger L. Severns, Harvey Hammond Talcott, Grove G. Talcott, Marjorie Grosvenor Van Horne, Ernest A. Wegner.

EDMUND W. BURKE PRIZE

In memory of the late Hon. Edmund W. Burke, Dean of the College from the year 1904 to the time of his death in 1918, members of his family have donated to the college a fund to be held by the trustees, the income therefrom to be used in providing such prizes as the trustees may deem suitable for students of the College who excel in oratory and debate. A prize of a graduate scholarship for the ensuing year was awarded to Horace Gilbert Marshall of the June class of 1932.

CALLAGHAN PRIZE

Messrs. Callaghan and Company, law book publishers of Chicago, offer a prize of fifty dollars in law books, for the best legal study prepared by a member of the senior class. This prize was awarded for the year 1932 to Paul Francis Kinnare. Honorable mention was made of Harvey Hammond Talcott and Paul McReynolds Jones.

DEBATE

General excellence in intercollegiate debate is recognized each year by the awarding of gold keys. Keys for the current year were awarded to Horace Gilbert Marshall, Roger L. Severns, and Edward B. Simon of the graduating class. Keys were also awarded to Russell J. Turney and John W. Cavanaugh of the class of 1933.

ROUNDTABLE

Elections to Roundtable will take place at the first meeting in September and will be based on scholarship standings attained during the year just past. An unusually interesting program has been planned for the monthly meetings by the executive committee under the supervision of the director, Professor Charles C. Pickett.
