History

The Library of International Relations was established in 1932 on the basis of documents provided by the League of Nations Association. The original LIR was hosted in a room provided by the John Crerar Library, staffed by Miss Eloise G. ReQua, founder and first director of the Library of International Relations. Miss ReQua's intent was to encourage the study of international affairs. By 1937, the Library resided at 86 East Randolph Street, where it remained until circa 1949 when it was transferred to 351 East Ohio Street. The Library was incorporated in 1960, and moved to 660 North Wabash Avenue in 1962. The collection was moved to Chicago-Kent College of Law campus at 77 S. Wacker Drive in 1983, when the Library became a part of IIT Chicago-Kent College of Law Library. The items in the collection are now a part of the collection at the downtown campus location at 565 West Adams Street in Chicago.

During the 1934 and 1935 seasons of the World's Fair, the Library maintained an exhibit known as the Story Cove on the Enchanted Island, a reading-room, library, and storytelling center. The Story Cove contained 1600 books in seventeen languages. The purpose of the collection was to give a wider international view of children's literature than the average American child was likely to have. Beginning in 1954 and ending in 2001, the Library of International Relations hosted the annual Consular Ball, both to honor the city's consular corps and to raise funds for the Library. In 1991, the Library became the first to develop an electronic imaging system, ELOISE, which allowed for instant access to rare materials for scholars worldwide.

Scope and Contents

The Library of International Relations collection contains records dating from 1933 to 2002 and fills 33 document boxes and 2 flat boxes. The extensive collection of papers date primarily from the 1980s and 1990s, although papers exist outside of those decades. The



substantial part of the collection is made up of Consular Ball records relating to planning of the event, also present are records of meeting minutes and member lists, and correspondence spans the entire collection. Financial records are also abundant, including extensive ledgers and balance sheets, annual and monthly statements, and early statements of stock ownership, as well as settlement records from Miss ReQua's estate. Miscellaneous records include bylaws, details on fundraising campaigns and development efforts, various records related to acquisitions and collection development, and records related to installation of artwork into the Library.

Separations

Oversized bound volumes were removed and placed in Boxes 34-35. Other items including a globe lapel pin, LIR logo pins, gold bookmarks, LIR medallions, an embossing press, and metal LIR logo plate, were removed and placed into artifact storage. Four floppy disks, one zip disk, one CD-ROM, and one audio cassette tape were removed and placed into AV storage. Approximately .83 linear ft. of clippings were removed and placed into clippings files, and approximately 1.67 linear ft. of photographs were removed and placed into photograph storage.
