FROM DEAN RICHARD MATASAR

On behalf of the faculty and staff of Chicago-Kent, welcome. You have made a wonderful choice of a school . . . and a profession. Your next three or four years promise working hard, finding intellectual challenges, making new friends, and committing--to study and serve.

You enter the profession with a real chance to make it better by your very presence.

Chicago-Kent should challenge you daily to engage your education, to seek ways of improving our profession, and to help make our society more just. We say here that your education gives you more than a license to practice law--you receive leadership training. I envy you your opportunity to become all that you can.

CAREER SERVICES NEWS

A Special Welcome to First-Year Students!

The Career Services Office is delighted to welcome you to Chicago-Kent. We look forward to meeting you and working with you as you begin your legal education.

Career services offices at law schools throughout the country do not provide career counseling services to first-year students before November 1 to comply with the requirements of the Association of American Law Schools and the American Bar Association Section of Legal Education (law school accrediting organizations), as well as the National Association for Law Placement standards. The National Association of Law Placement Principles and Standards state that first-year students and prospective employers should not initiate contact with one another before December 1.

These provisions were developed to insure that during the first few months of law school, first-year students concentrate on their legal studies rather than on the job search process. There is one exception--evening students seeking non-legal employment may visit the Career Services Office before November 1.

In early November, we will offer a series of programs designed specifically for first-year students. The date of the programs will be announced in *The Record*. The programs will tell you about our services and address the realities of the job market, how to structure a summer job search, and how to write a legal resume.

First-year students are encouraged to attend informational programs we will offer this fall on a variety of topics. Watch *The Record* for program subject matter and times. During orientation week, pick up a copy of *Careerline*, our office newsletter, for more career information and advice about law school from second- and third-year students. On Friday, the Student Careers Committee will have a table set up during the pizza party--stop by to meet committee and staff members.

There are some administrative matters that warrant mentioning. First, the Law Library maintains its pleasant work atmosphere through the enforcement of its no eating, drinking, chewing (as in tobacco) and dipping policy. If you have something you want to eat or drink later, it must be left in your locker. If we see it, it is subject to confiscation.

Second, this Law Library, like most law libraries, is a self-shelve library. Any materials you retrieve from the shelves **MUST** be reshelfed before you leave the library. Materials left overnight will be reshelfed within the first hour of operation the following day. If for some very good reason you cannot reshelve your materials, at least take them to one of the four sets of distribution shelves located on floors 6 through 9.

The Law Library staff is here, ready and willing to assist you in your law studies. Each week the Reference staff will be offering tutorials on research in a number of legal topics. Look for this and other Library information and updates in the Library section of *The Record* and on the 9th floor Library bulletin boards.

NEWS FROM THE CENTER FOR LAW AND COMPUTERS

Welcome to an exciting and challenging year! Throughout this first week of law school, the Center for Law and Computers (Center) will offer instruction about integrating law and technology, guide you to some of the basic resources available at Chicago-Kent, and help you be the best law student you can be. To fully use the technology resources available at Chicago-Kent, you will need a copy of the materials that include a reference manual for many of the resources here, that is now available in the Chicago-Kent Bookstore. This manual is a **required** purchase for all first year students.

More resources are available to you than ever before. Take time during this first week to visit the computer labs, log on to the network, read and send email messages, and examine the Kentnet menu so that you are

ready to use whatever you need to succeed in law school. There are student leaders, lab assistants and Center faculty and staff ready to answer questions and show you how to get the most out of Chicago-Kent.

On Friday, August 19, 1993, the Computer Law Association (CLASS) will conduct a Computer Clinic in Room 345. Bring your CPU's, but no monitors or keyboards, if you want the members of CLASS to configure your system, install software, etc. During this first week, contact the representatives of LEXIS and WESTLAW here at the school to obtain your copy of their software for installation at the Computer Clinic. The Computer Clinic will be open from 8:00 a.m. until 4:00 p.m.

Also on Friday, August 19, the Center will sponsor a Computer Fair. Computer software and hardware vendors have been invited to demonstrate their products to all students, faculty and staff. The vendors will be available to talk with you from 12:00 noon until 6:00 p.m. in the first floor lobby.

Every week, the Center provides valuable information about new computer software releases and instructions, new resources available through Kentnet and dial-in access to Kentnet, and other news in *The Record*. Look for information on CLASS in *The Record* or contact Dom Grillo (DGRILLO). Read *The Record* every week to stay updated on the technology resources available to you.

STUDENT BAR ASSOCIATION

As president of the Student Bar Association, I would like to welcome you to Chicago-Kent! All of you are just beginning what now seems like a long three or four years of law school classes and exams. But, let me be the first to tell you that the time flies by and before you know it, you will be graduating and telling others that it was not that bad.

I wanted to take this opportunity to tell you a little bit of what the Student Bar Association is all about and how you can become active in the many different student organizations here at Chicago-Kent.
