MESSAGE FROM DEAN MATASAR

On behalf of the faculty and staff of Chicago-Kent, welcome. You have made a wonderful choice of a school . . . and a profession. Your next three or four years will find you working hard, finding intellectual challenges, making new friends, and committing -- to study and serve.

You are coming to the law school at an exciting time. Our program is evolving daily, with new courses, new concentrations, and new faculty members. We say here that your education gives you more than a license to practice law -- you receive leadership training. I envy you your opportunity to become all that you can.

REMINDER: COMING LATE, LEAVING EARLY

Some instructors enforce a classroom policy that sanctions students who arrive late or leave early. They impose tardiness policies not to penalize students but to create a classroom atmosphere conducive to learning. Other instructors believe that adults with busy lives may have excellent reasons to be somewhere else for part of their class time. Regardless of whether an instructor chooses to be severe or lenient on this matter, however, students who walk into class late, or leave before dismissal, disrupt the lesson. For classes without a stated policy, we ask that you consider the costs to your classmates that arise if the time limits of the class are not respected. When doors open and close noisily, speakers are interrupted in mid-sentence, and concentrated thought is diverted, the rest of the class pays a price that may exceed the benefit of one individual's being elsewhere.

CAREER SERVICES NEWS

A Special Welcome to First-Year Students!

The Career Services Office is delighted to welcome you to Chicago-Kent. We look forward to meeting you and working with you as you begin your legal education.

Career services offices at law schools throughout the country do not provide career counseling services to first-year students before November 1 to comply with the requirements of the Association of American Law Schools and the American Bar Association Section of Legal Education (law school accrediting organizations), as well as the National Association for Law Placement standards. The National Association of Law Placement Principles and Standards state that first-year students and prospective employers should not initiate contact with one another before December 1.

These provisions were developed to insure that during the first few months of law school, first-year students concentrate on their legal studies rather than on the job search process. There is one exception -- eventing students seeking non-legal employment may visit the Career Services Office before November 1.

In early November, we will offer a series of programs designed specifically for first-year students. The date of the programs will be announced in the Record. The programs will tell you about our services and address the realities of the job market, how to structure a summer job search, and how to write a legal resume and cover letters.

First-year students are encouraged to attend informational programs we will offer this fall on a variety of topics. Watch the Record for program subject matter and times. During the first weeks of school, pick up a copy of Careerline, our office newsletter, for more career information and advice about law school from second- and third-year students. On Thursday and Friday, the Student Careers Committee will have a table set up during the orientation pizza parties -- stop by to meet committee and staff members.

The Information Center staff would like to welcome new Chicago♦Kent and Stuart School students and welcome back all returning students. The Information Center encompasses the libraries of the IIT-Downtown Campus -- the Law Library, the Library of International Relations, and the Business Library. Together, they are an outstanding collection of law and business materials containing more than 475,000 volumes plus two million pages of imaged materials available electronically.

The "hub" of the Information Center is the Library Service Desk (LSD) located at the 9th floor main entrance. Circulation and Reference are located at the LSD -- the professional Law Librarians are available for reference assistance during most of the hours the Information Center is open. The Librarians are trained in library science and also have law degrees or other advanced degrees; they are able to assist with research in all the

subject areas of the collection. The reference staff will be involved in legal research and online databases training.

Using computers to save, store, search, retrieve electronic information and text; using VIEWS software for managing information.
- 4:00-4:55: The Internet Through the World Wide Web and Usenet
Accessing the World Wide Web browser within the law school; general overview of Internet, including sending and receiving email, the "Web," and Usenet; network etiquette ("netiquette"). This session is designed for the non-technical computer user.

Volunteers Needed
