FROM DEAN MATASAR

Judicial Clerkships

Judicial Clerkships: An Informational Program--Special Attention to 1997 Graduates

A special program on the value of a judicial clerkship as an entry level career opportunity will take place on Thursday, October 25 at 5:00 p.m. in the auditorium. Judicial clerkships are post-graduation full-time positions on the staff of judges. Most federal judges hire clerks 12 to 18 months before employment starts; state judges hire clerks 1 to 12 months before employment starts.

Chicago-Kent professors Susan Adams, Michele Baker Richardson and Richard Warner will discuss the responsibilities of clerks, the advantages of a judicial clerkship, and the application and selection process. Professor Vivien Gross will discuss the Faculty Judicial Clerkship Committee and its advisory role.

All students, including first year students, are invited to attend the program. However, our experience has shown that most clerkships are awarded to students in the top third of their class. Students graduating in 1997 are particularly urged to attend because applications to most federal and some state judges for 1997 clerkships need to be made in early spring of 1996.

NEWS FROM THE CLC (CENTER FOR LAW AND COMPUTERS)

Email System Upgraded

A new version of ExpressIT! (Chicago-Kent's email package) has been installed for DOS and Windows. Although almost everything is the same, there are a few new features the Center would like you to know about.

1. The **OUTBOX!** -- Copies of sent messages are now kept in a folder called **OUTBOX**, instead of the **DELETED** folder. An unlimited number of messages is available for 7 days; the old **DELETED** folder held only 50 messages. File attachments are not saved in the **OUTBOX**. The **DELETED** folder still holds the mail you delete.
2. At startup and shutdown, the **MAIL LOG** (where outgoing registered mail is kept) is automatically purged to remove any messages older than 60 days. File attachments are no longer saved in the **MAIL LOG** folder.
3. From the main menu of any folder, the **TAB** key pops up a folder list to help you move from folder to folder.

Information Center Acquires 500,000th Volume

The Information Center joins an elite and select group of law libraries with collections totalling at least 1/2 million volumes with the acquisition of The Rules and Regulations of the Singapore Exchange. These exchange rules are the first in a series of acquisitions; the Info. Center plans to have the rules and regulations of all the World's major futures exchanges available electronically on LOIS. Currently, the Center has the rules of the Chicago, New York, Sydney, Singapore, and Hong Kong exchanges.

Library of International Relations Sponsors Conference

On October 6-7, the Library of International Relations welcomed attendees and speakers from around the world to "Public Policy and Global Technological Integration." The symposium was led by Professors Abbott and Gerber and included sessions on the Impact of New Technologies, the WTO TRIPS Agreement and Global Economic Development, a Competition Law Approach to Global Intellectual Property and Telecommunications Market Integration, along with many other sessions.

In addition to making all the conference arrangements, the Reference Staff of the Information Center prepared a section for the conference proceedings, "Researching International Law and Global Technological Development," which highlighted the research sources of the LIR and included international databases and Internet sources.

Supreme Court Hears Arguments on Colorado Statute

On October 10, the U.S. Supreme Court heard oral arguments in Romer v. Evans, the case challenging Amendment 2 to Colorado's state constitution. The voter-approved amendment nullifies all state and local laws protecting homosexuals against discrimination and bars such laws from being enacted in the future. News reports stated that argument before the Court was vigorous, not only on the part of the attorneys but also the Justices. The text of the statute and a report of the oral arguments can be located online in the NYT file on Lexis/Nexis and U.S. Law Week will include coverage. The Colorado Supreme Court decisions can be found at 854 P.2d 1270 (Evans I) and 882 P.2d 1335 (Evans II).

FACULTY NEWS

Professor Anita Bernstein and her co-author, Paul Fanning, will publish their article, "Weightier Than a Mountain: Duty, Hierarchy and the Consumer in Japan," in the January issue of the Vanderbilt Journal of Transnational Law. The article is the second of a series that Prof. Bernstein and Mr. Fanning have written for this journal, on the relationship between national culture and products liability reform.

**SPRING 1996 APPLICATIONS AVAILABLE IN ROOM 600
DUE MONDAY, OCTOBER 30**

Students who would like to learn how to practice law while they are in law school should register for the in-house clinical education program, **LAW OFFICES**. Applications are now available for spring. The spring applications are due October 30.

Students may enroll in Law Offices after they have completed their first year of law school (current first years may not apply for Spring 1996). To be eligible to enroll, **ALL** students (except LADR students) must complete and return a completed Law Offices application. Applications must be turned in to the Law Offices receptionist in Suite 600 by the deadline.

Students who have taken or are currently taking Law Offices (called Continuing Law Offices Students) and who submit their applications by the due date will be given preference if availability permits. Next, priority will be given to the top ten students on the fall 1995 waiting list who did not turn down a place, who were on the waiting list in the division they have marked as first choice, and who submitted their spring application by the due date. Other new students who have submitted their applications by the due date will be selected in the Law Offices lottery.

The in-house programs are comprised of two components. One is a graded classroom component for one credit. The other is a pass/fail three credit fieldwork component. For the fieldwork component students work in practice groups on client cases or similar projects assigned to them by a supervising attorney. It also includes practice group lectures, supervising attorney conferences, section meetings, and various client interview experiences.

There are six in-house practice groups from which to choose - employment discrimination/civil rights with some general practice, criminal defense, mediation and other ADR procedures, health law, immigration, and tax.

For more information, you may talk to the clinical professors who supervise the various practice groups - Professors Gonzalez (Rm. 629) and Norton (Rm. 623) for employment discrimination/civil rights with some general practice; Professors Kadish (Rm. 613), Kling (Rm. 625), and Thomas (Rm. 609) for criminal defense; Professor Kentra (Rm. 690) for mediation and other ADR procedures; Professors Elster (Room 692) and Toolan (Room 621) for health law; Professor Benitez (Rm. 627) for immigration; and Professor Livingston (Rm. 688) for tax.

Advanced Externship Program Spring, 1995

THIRD YEAR STUDENTS ONLY:

Do you wish to develop your legal skills? Gain practical legal experience in a specialized area of law with a corporation, firm or government agency? Make yourself more marketable to prospective employers upon graduation? If you have answered "yes" to any of the above questions, consider applying for the Advanced Externship Program for Spring Semester 1995.

The Advanced Externship Program is a four credit hour program consisting of a 3 credit hour fieldwork and a 1 credit hour classroom component. The program is open to students in their last two semesters of law school. For the fieldwork component, an extern is placed in a private or public, civil or criminal practice and is required to work a minimum of 15 hours a week at his/her designated placement. Externs interested in civil law may

select to work under the supervision of general counsel in major corporations or under the supervision of designated teaching lawyers in well-known firms or specific government agencies. Externs may specialize in such diverse legal areas as tax, commodities, securities, corporate, health care, medical malpractice, and general corporate law, etc. Those interested in criminal law may select to work with designated supervising lawyers at the States Attorney's Office, Public Defender's or the U.S. Attorney's office. Many externships may offer the externs opportunities to obtain a 711 license and appear in court.

The accompanying classroom component consists of a 1 hour class weekly, which focuses on various aspects of today's practice of law and on the externs' fieldwork experiences.

If you are interested in learning more about externship opportunities or in applying for the program, please see Professor Vivien Gross in Room 617.

More information about the program and an accompanying application form are available in the Law Offices Reception Area. Applications must be turned in to Room 612 by 5:00 p.m. on Wednesday, November 1. All applicants must have scheduled and completed an interview with Professor Gross prior to turning in their applications. Slots are limited. In the event applicants outnumber the number of students that can be accepted in the program, students with at least one semester of Law Offices or LADR (Law Alternative Disputes Resolution program) will receive a preference over other students in being admitted in the Externship Program.
